- As per provision of clause 7(13) of the NCTE Regulations, 2014, as amended from time to time, the process of appointment of qualified staff as per policy of the State Government or University Grants Commission or University, may be initiated by the institution, and the affiliating body will provide all assistance to the institution to ensure that the staff or faculty is appointed as per norms for the course. The institution shall submit the list of faculty, duly approved by the affiliating body, to the Northern Regional Committee within two months from the date of Letter of Intent.
- In this regard, as per decision taken by NRC in its 199th meeting, it is clarified, that the above implies that where there exists a provision of nomination of expert/experts for the Selection Committee by the affiliating university, the same be adhered to. In the absence of such a provision in the Act/Statutes of the affiliating university, the institution shall select faculty members by employing a transparent, objective and judicious process and shall get the list of selected faculties duly approved by the affiliating university. This approved list, along with details of educational qualifications and teaching experience, shall be submitted by the institution to the Northern Regional Committee.
- As per Regulations, 2014, an institution can be given two units initially for D.El.Ed., B.Ed., B.A.B.Ed./B.Sc. B.Ed. courses subject to fulfillment of other conditions such as, land and built-up area, etc. However, in case of B.El.Ed., B.P.Ed., M.P.Ed., B.Ed.-M.Ed. courses, only one unit can be given initially. Further, an institution can be given maximum two units of B.Ed. course, meaning thereby, no additional unit shall be given if an institution is already having two units of B.Ed. course.
- In view of the above, before grant of formal recognition under clause 7(16) of the NCTE Regulations, 2014 is considered by the NRC, the following documents are required to be submitted by the institution: -
- The institution shall submit particulars of the staff duly approved by the University/affiliating body in the prescribed format available on the NRC, NCTE website.
